## Item 4 Other Business Activities

Olac Pallan Gayol is a Registered Representative with Emerson Equity LLC. Emerson Equity LLC is a diversified financial services company engaged in the sale of specialized investment products. In this capacity, Mr. Pallan Gayol may recommend securities or insurance products offered by Emerson Equity LLC as part of your investment portfolio. If you purchase these products through Mr. Pallan Gayol, he will receive the customary commissions in his separate capacity as a Registered Representative of Emerson Equity LLC.

Additionally, Mr. Pallan Gayol could be eligible to receive incentive awards such as Emerson Equity LLC may offer. He will also receive 12b-1 fees from mutual funds that pay such fees. The receipt of additional compensation will give Mr. Pallan Gayol an incentive to recommend investment products based on the compensation received, rather than on your investment needs.

Olac Pallan Gayol has a fiduciary duty to act in your best interest when acting in an investment adviser representative capacity, including the duty to seek best execution. Therefore, our Company's mutual fund selection and recommendation process takes into consideration several factors in order to meet this requirement. See the ADV Part 2A Brochure, the *Brokerage Practices* section, for additional information on our mutual fund share class selection process.

As stated above, persons providing investment advice to advisory clients on behalf of our firm are registered representatives with Emerson Equity LLC. In their capacity as registered representatives, these persons receive compensation in connection with the purchase and sale of securities or other investment products, including asset-based sales charges, service fees or 12b-1 fees for the sale or holding mutual funds. Compensation earned by these persons in their capacities as registered representatives is separate and in addition to our advisory fees. This practice presents a conflict of interest because persons providing investment advice to advisory clients on behalf of our firm who are registered representatives have an incentive to recommend investment products based on the

compensation received rather than solely based on your needs. Persons providing investment advice to advisory clients on behalf of our firm can select or recommend, and in many instances will select or recommend, mutual fund investments in share classes that pay 12b-1 fees when clients are eligible to purchase share classes of the same funds that do not pay such fees and are less expensive. This presents a conflict of interest. You are under no obligation, contractually or otherwise, to purchase securities products through a person affiliated with our firm.
